Last time I wrote to you, you moved house and it is on your facebook page that you are moving again.

It seems to me that as public awareness rises you try to move away from the situation.

However the reality is that you can not simply run away from this.

I do not want your family and friends suspecting your actions nor do I want people watching everything you do.

All you really need to do is publicly deny what people are accusing you of and give a truthful reason for doing so.

If you can not do this for any reason and you want to explain why to me, just email me.

You talked about who could you trust in your last video, the only person that has treated you fairly in this matter is me.

All I have ever done is truthfully reply to comments that you made of your own free will.

I did make some of them into short videos to prove the point that what you were saying is incorrect, but that is all.

I have treated you with respect through out this investigation and have often invited you to give your point of view.

I have considered the comments that you left fairly, others have been a bit more critical of you, but they, like you, are entitled to reply.

If you need to get out of Ammanford I have a small farm abroad, work with me and its yours for as long as you need it. I could even have someone meet you in Hoek van Holland but you would need to get to Harwick.

You really need to start putting yourself and your family first, before the needs of others. Others who will abandon you when it suits them.

You might want to take a bit of time and read over my letter a few times, my letter is written to try to help you through the difficult situation you find yourself in.

If I do not hear from you I will send the same three sheets to one of the other nine people on my list, and see if I get a response, rest assured I will not tell anyone else that I contacted you first.
